DID YOU KNOW???

SCHOOL HAS RESUMED; SCHOOL SPEED LIMITS ARE IN EFFECT

School has begun this year with in-class learning after a year of hybrid learning. Thus, school speed limits are in effect on school days. Some of our school speed zones are controlled by flashing beacons that mandate the school speed limit "WHEN FLASHING" rather than specific times. Whenever the beacons are flashing, the school speed limit is in effect, even in evenings for school events. Furthermore, speeding fines are doubled if convicted of violating a school speed limit.

Another issue to be aware of as school resumes this fall is that in many schools, start times may be staggered to allow for fewer students on school buses and in classrooms. Thus, students may be going to school at different times and the same for going home after school. Drivers are likely to see students earlier in the morning and later in the afternoon than they may be used to.

Drivers need to be aware of stopped school buses and obey the NO PASSING A STOPPED SCHOOL BUS WHEN LIGHTS ARE FLASHING law. Incredible as it may seem, it is estimated that 50,000 motorists illegally pass a stopped school bus in New York State EVERY SCHOOL DAY. If you are convicted of passing a stopped school bus, five violation points are assigned to your driving record by NYS DMV. As schools and school buses resume after summer vacation, be extra careful in the vicinity of schools and be aware of the potential for stopped school buses anywhere. For those parents that drive their student to school be aware that it is also illegal to pass a stopped school bus with red lights flashing on school property.

Lastly, many of our schools have crossing guards at busy intersections in the vicinity of schools. When they step out into the street with their STOP sign, drivers need to obey them. It may cost you a few extra seconds on your journey but what's a few seconds compared to the consequences of hitting a student? Be alert. No one wants to injure a child.

FROM SOIL & WATER:

The walls were poured and removed to allow to cure before backfilling could start.



The farm had started to store manure and milk house waste in the storage while waiting for the project to be finished.

The District was awarded funds for Agricultural Non-Point Source and Abatement Control Program Round 24 for the installation of a new concrete waste storage and transfer components. The project is for a 125 cow dairy farm in the Town of Stark. The new storage would increase the farms storage from 2 months of storage to 8 months of storage while protecting valuable ground and surface water resources. The new storage would hold just over one million gallons including manure, milk house waste, and precipitation. The storage is nearing completion and the farm has started to utilize the storage.

Japanese Knotweed Project Update



This marks the 3rd year of treating several high priority infested sites for the Herkimer County Japanese Knotweed Project. The project began in 2016 as a whole county inventory project, covering every road in Herkimer County. We have investigated and inventoried more than 1,000 sites infested with Japanese Knotweed along roadsides, streams and ditches. Sites are prioritized based on water quality concerns with District Board approval and landowner permissions before treating any prioritized sites. We can treat a limited number of sites each year, so we are not taking on new sites.



The treatment season is typically between mid-August and the end of October while the knotweed plants are flowering, until the first major frost event. Eradication at a single site infestation takes several years. Individual sites take several hours for our staff to treat, as each and every stalk is treated by stem injection. This year, district staff became fully certified pesticide applicators under the district's agency registration with the NYS DEC, an upgrade from pesticide technician status. Below are before treatment (2019) and after two treatments (2021) photos of a site located along a blue line trout stream C(TS) off of Beecher Rd in the town of Russia.

By the end of the 2021 treatment season, our staff plans to have treated in five towns. Our ultimate goal is to eradicate all high priority sites within the county, thus promoting native species growth. Herkimer College awarded



Prestigious National Science Foundation grant

Herkimer County Community College has been awarded a prestigious grant from the National Science Foundation (NSF) to better serve underrepresented minority students pursuing a science, technology, engineering, or mathematics (STEM) degree.

The grant was awarded through the NSF's Louis Stokes Alliances for Minority Participation (LSAMP) program and is part of an overarching goal to diversify the STEM workforce. The College's allotment under the nearly \$2 million grant is \$242,381 over a five-year period.

The College was awarded these funds in partnership with six other regional colleges—Ithaca College, Utica College, State University of New York at Cortland, SUNY College of Environmental Science and Forestry, Hobart and William Smith Colleges, and Tompkins Cortland Community College—a coalition known as the Central New York LSAMP Alliance (CNYLA).

Thanks to the CNYLA, LSAMP scholars will have a specialized transfer path to one of the participating four-year schools, in addition to the more than 150 articulation agreements Herkimer College already provides. "With the LSAMP scholars cohort, we can take a student all the way from their associate degree to a doctorate in STEM," said Dr. Jennifer Adjodha-Evans, Herkimer College's LSAMP campus facilitator. She also serves as one of only three principal investigators for the CNYLA and is an alumna of an LSAMP "Bridges to Doctorate" program.

Herkimer College LSAMP scholars will develop their research skills by designing, conducting, and reporting on their own original undergraduate research projects, and will participate in various STEM career awareness and readiness programs. There will also be a mentorship component and specialized transfer support to help LSAMP scholars move on to bachelor's and eventually graduate-level STEM degree programs.

Herkimer College announces new mission, vision statements as first step in developing a new strategic plan

The Herkimer County Community College Board of Trustees has approved new mission and vision statements for the College, as part of a strategic planning process.

Mission Statement: Herkimer College's mission is to provide dynamic educational programs and services in an inclusive, engaging community where all learners have the opportunity to grow and succeed.

Vision Statement: Herkimer College will be the college of choice, delivering an innovative, transformative student experience inspired by a new generation.

The new mission and vision statements were developed through a collaborative, inclusive process that began in January 2021. An Institutional Effectiveness (IE) Planning Committee was responsible for creating the new statements, with input from faculty, staff, and students. With new mission and vision statements in place, the IE Planning Committee will begin working on the strategic plan goals, objectives and action items, with input from various stakeholder groups.

"The revised mission and vision statements provide critical guiding principles for our institutional planning," said President Cathleen McColgin. "Our vision for Herkimer College is progressive, and I believe it provides us with the inspiration and adaptability for an exciting future."



Herkimer College welcomes students back to campus

Herkimer County Community College welcomed nearly 800 students to campus for the fall semester. An additional 650 students are enrolled entirely online through the College's Internet Academy. Of the 800 on-campus students, just over 300 are living in on-campus housing.

We are committed to providing a safe campus environment for all students, employees, and visitors. In accordance with the State University of New York policy, proof of full vaccination is required for all students enrolled in on-campus classes or planning to be on campus for any reason, with some approved medical and religious exemptions. Throughout the semester, all residential students, commuter students who are unvaccinated, and unvaccinated employees are required to participate in regular COVID surveillance testing. The College also currently has a mask mandate in place for all individuals, regardless of vaccination status.

On August 2nd, at a luncheon held at Hart's Hill, Legislative Chairman Vincent J. Bono recognized Mohawk Valley Community Action Agency as they celebrated 55 years of helping families in Oneida and Herkimer Counties cross the bridge out of poverty.

MCVAA has been the frontline resource by providing direct services and support for education, employment and family support services. They connect families living in poverty with Early Head Start, Head Start, and Universal Pre-K , utility assistance, tax preparation; Housing Assistance, Senior Services, Weatherization, Foster Grandparents and Youth Services. MVCAA is the pro-active voice in the community for those who don't often have the capacity to speak for themselves. The Herkimer County College Corps Internship Program is targeted at those residents who will be entering their junior or senior year in college. It is a 200 hour experience designed to closely correlate with the student's current field of study. It is a way that young people who have left the area to go to college can realize that there are good employment opportunities in their career choice right where they grew up!

This year, a young man named Beny Huckaby was placed in an internship with the Town of Webb Tourism Center. Beny attends Vassar College enrolled as a Science, Technology and Society Major with a Minor in Film and is scheduled to graduate in 2023.

According to Mike Farmer, Town of Webb Tourism's Publicity Director, the organization "could not have been happier or more impressed with Beny's intelligence, work ethic, productivity or quality of work..." Farmer adds that their experience with Beny "capsulizes what we have been looking for, not only as an intern, but as an employee..." The feeling that was brought on by the combination happenings was heavy. A town seeing the light on the other side of COVID 19, the beautiful scenery and fading sunset, the fireworks going off loud and proud above the town, while at the same time helping those less fortunate. The Herkimer Home State Historic Site is a historic house museum situated overlooking the Mohawk River on Route 169 in Little Falls. It was built in 1764 by General Nicholas Herkimer who died there in 1777 from wounds suffered in the Battle of Oriskany. Visitors are invited to tour the mansion and view the visitor center exhibits; and also explore the grounds to discover General Herkimer's final resting place, a recreated kitchen garden, remnants of an Erie Canal lock, and scenic views of the Mohawk River.

For the last 3 summers, through our Summer Youth Employment Program, Lucas Miller has been placed at this site as a groundskeeper making sure that the site looks good for the tourists who come to visit. His supervisor, Paula, shared this picture of him hard at work. She says he is "a true gem" and she is so happy that he has been placed with them. 

FROM CORNELL COOPERATIVE:

A new and very destructive insect pest is heading towards Herkimer County. The spotted lanternfly, native to China and Southeast Asia was discovered in Pennsylvania in 2014. Since then it has been expanding its range and is a threat to agriculture and home gardens throughout the United States. Currently it is well established in Eastern Pennsylvania and many counties in New York. Individual specimens have been found in Herkimer County, but not breeding colonies of the insect. The spotted lanternfly is a prolific breeder with a taste for the sap of some of our most valuable trees and vines. Amongst the many plants effected are: grapevines, apple, maple and black walnut trees, among many others. The lanternflies also exude honeydew a sticky substance that attracts bees, wasps and other insects as well as promoting the growth of mold and mildew on the trees.

You can spot adult lanternflies very easily. They are strikingly colorful with red hind wings, black spots and a yellow abdomen with black bands. Once established in an area you will see masses of them on tree trunks and vines. Their preferred host are Tree of Heaven (*Ailanthus altissima*) and grape vines, but will attach themselves to many other plants. Unfortunately, swarms of the insects will create unsightly messes and interfere with the enjoyment of parks and backyards as well as hurting the income of farmers.



To help combat this pest there are several things that you can do. First of keep an eye out for them and take a picture of the insect and, if possible, include something in the photo like a coin or a ruler for size reference. Collect it in a bag if you can and freeze it or in a jar with rubbing alcohol or hand sanitizer. Note the location by street address or zip code or GPS data and send the information to: and reporting sightings to: spottedlanternfly@dec.ny.gov

At this time, Cornell is a leading center for research into how to stop the lanternfly before it becomes established and hurts the apples, hops and grapes that the insect attacks. Recently, university researchers discovered two native fungal pathogens that kill lanternflies and are currently working on methods to use them as a natural control. Until then, please report any sightings and kill individual insects when you see them.


