#### RESOLUTION SUPPORTING CONCEPT OF A CHILDREN'S CENTER

#### **Sponsored by: Committee on Human Resources**

WHEREAS, Herkimer County has acknowledged an unmet need for certain services in the community for children and families; and

WHEREAS, employers in Herkimer County are in need of employees; and

WHEREAS, there is insufficient daycare in Herkimer County; and

WHEREAS, the poverty rate in the corridor from Frankfort to Little Falls is 34.8% for children ages 0-5; and

WHEREAS, there is a critical need to keep and attract younger individuals and families in and to the county, as the population has dropped and aged by 10% over the course of the last decade; and

WHEREAS, there is a shortage of children's mental health services as well as a shortage of physical therapy, occupational therapy and speech therapy providers; and

WHEREAS, access to specialized pediatric health services continues to be limited; and

WHEREAS, Herkimer County continues to suffer from poor maternal and child health outcomes, necessitating support services such as lactation counseling and childbirth education; and

WHEREAS, Herkimer County is a designated "food desert", requiring services that will provide food access to families: and

WHEREAS, a one stop center for these services will be more advantageous for children and beneficial to the parents; now, therefore, be it

RESOLVED, that the Herkimer County Legislature agrees with the concept of a children's center complete with the supports of childcare, a BOCES Pre-K classroom, a children's mental health clinic, developmental pediatric services, early intervention therapy, Mohawk Valley diaper bank, UCP developmental playgroup, Connected Community Schools hub, childbirth education and lactation counseling, EFNEP nutrition education, local food access support, and a preceptorship site for Herkimer College, pending the selection of the site and the ability to finance the project; and, be it further

RESOLVED, that certified copies of this Resolution be forwarded to the County Administrator, Budget Officer, Director of Public Health, and Commissioner of Social Services.
