WHEREAS, a Project for the Replacement of the Peckville Road, CR148 Bridge over Gillette Creek (BIN 3307770), Town of Manheim, Herkimer County, PIN 2754.92.121 ("the Project"), Project No. 431 is eligible for funding under the Title 23 U.S. Code, as amended, that calls for the apportionment of the costs of such program to be borne at the ratio of 80% Federal funds and 20% non-federal funds; and

REPORT AND RESOLUTION CONCERNING THE ESTABLISHMENT OF THE HERKIMER COUNTY LAND BANK CORPORATION AND APPOINTING BOARD

MEMBERS TO SERVE ON THE HERKIMER COUNTY LAND BANK BOARD OF DIRECTORS

Sponsored by: Committee on Administration and Veterans Affairs Committee on Ways and Means

WHEREAS, New York State has recognized the need to provide new tools and innovative solutions to address deteriorated, abandoned and tax-delinquent properties and the blight they inflict upon communities; and

WHEREAS, land banks allow and provide a mechanism for the re-development, repair, improvement, or in appropriate situations, deconstruction of blighted properties; and

WHEREAS, land banks have now been firmly established nationally, with a success record in helping to ameliorate the above negative impacts; and

WHEREAS, in recognition of same and in order to revitalize and strengthen local communities and economies, New York State has adopted a Land Bank Act ("Not-For-Profit" Corporation Law, Article 16); and

WHEREAS, by letter of Michael L. Edwards dated November 13, 2023, request has been made for Herkimer County to take necessary steps to form a land bank as set forth in the New York State Article 16, "Land Bank Act"; and

WHEREAS, the Herkimer County Legislature desires to create a county-wide land bank in order to efficiently and effectively address blight within Herkimer County; and

WHEREAS, in accordance with the Land Bank Act, it is necessary to adopt a resolution establishing the Herkimer County Land Bank Corporation ("HCLBC") and addressing requirements relating to the structure and function of the HCLBC; now, therefore, be it

RESOLVED, that the County of Herkimer hereby establishes and authorizes the creation of the Herkimer County Land Bank Corporation, as follows:

- 1. Name of the land bank: Herkimer County Land Bank Corporation;
- 2. The number of members of the Board of Directors, which shall consist of an odd number of members, shall be not less than five members nor more than 15 members.
- 3. The initial seven individuals to serve as members of the Board of Directors, and the length of terms they shall serve as appointed by the Chairman of the Legislature and confirmed by the County Legislature shall be as follows:
 - (a) Peter Campione, County Legislator, initial term of 2 years;
 - (b) Raymond Donley, County Legislator, initial term of 2 years;

- (c) Gregory Malta, Sr., County Legislator, initial term of 1 year;
- (d) James W. Wallace, Jr., County Administrator, initial term of 2 years;
- (e) Kimberlee Enea, County Treasurer, initial term of 2 years;
- (f) Donald Dutcher, Community Member, initial term of 1 year;
- (g) Vincent Bono, Community Member, initial term of 1 year.
- 4. The members of the Board of Directors shall be residents of Herkimer County. The regular terms of office of members of the board of directors shall be two (2) years, in addition to any partial term for which a member is appointed to fill a vacancy.
- 5. The proposed articles of incorporation and bylaws of the HCLBC are approved for inclusion in the application for the HCLBC which is to be sent to Empire State Development.
