LOCAL LAW NO. 1 - 1993

A LOCAL LAW INCREASING THE SALARIES OF SOME ELECTED COUNTY OFFICERS AND COUNTY OFFICERS APPOINTED FOR A FIXED TERM DURING THEIR TERM OF OFFICE

BE IT ENACTED by the Herkimer County Legislature of the County of Herkimer as follows:

Section 1. The base annual salary of the County Administrator shall be the sum of forty two thousand, three hundred ninety-four dollars (\$42,394.00).

Section 2. The base annual salary of the County Auditor shall be the sum of twenty seven thousand, four hundred fifty-eight dollars (\$27,458.00).

Section 3. The base annual salary of the Budget Officer and Purchasing Agent shall be the sum of thirty one thousand, eight hundred dollars (\$31,800.00).

Section 4. The base annual salary of the Real Property Tax Director shall be the sum of thirty thousand, seven hundred forty dollars (\$30,740.00).

Section 5. The base annual salary of the County Clerk shall be the sum of thirty three thousand, thirty-four dollars (\$33,034.00).

Section 6. The base annual salary of the County Attorney shall be the sum of thirty five thousand, eight hundred fifteen dollars (\$35,815.00).

Section 7. The base annual salary of the Commissioner of Social Services shall be the sum of forty seven thousand, two hundred seventy-six dollars (\$47,276.00).

Section 8. The base annual salary of the County Highway Superintendent shall be the sum of forty nine thousand, five hundred forty-four dollars (\$49,544.00).

Section 9. The base annual salary of the County Sheriff shall be the sum of thirty eight thousand, one hundred sixty dollars (\$38,160.00).

Section 10. The base annual salary of the Director of Probation shall be the sum of thirty three thousand, four hundred twenty-seven dollars (\$33,427.00).

Section 11. The base annual salary of the Director of Public Health shall be the sum of forty six thousand, four hundred fifty dollars (\$46,450.00).

Section 12. The base annual salary of the Director of Mental Health shall be the sum of forty eight thousand, nine hundred forty-eight dollars (\$48,948.00).

Section 13. The base annual salary of the Director of Data Processing shall be the sum of thirty five thousand, eight hundred fifteen dollars (\$35,815.00).

Section 14. The base annual salary of the Director of Office for the Aging shall be the sum of twenty seven thousand, four hundred fifty-five dollars (\$27,455.00).

Section 15. The base annual salary of the Coordinator of Public Safety shall be the sum of five thousand, two hundred thirty-two dollars (\$5,232.00).

Section 16. The base annual salary of the County Coroners shall be sixty-five dollars per call (\$65.00).

"Salary Schedules for 1993 and ensuing years shall include annual increments and longevity increments as they apply to each officer on December 31, 1993."

LOCAL LAW NO. 2 - 1993

A LOCAL LAW REGULATING PARKING ON COUNTY OWNED OR COUNTY LEASED PROPERTY

BE IT ENACTED by the Legislature of the County of Herkimer as follows:

Section 1. Definitions

"Park" or "Parking" means the standing of a vehicle, whether occupied or not, otherwise than temporarily for the purpose of and while actually engaged in loading or unloading merchandise or passengers.

"Parking Lot" Any area or areas of property owned or leased and/or in the control of the County of Herkimer, designated by resolution of the Legislature of the County of Herkimer as a parking lot, and intended for use of officers and employees of the County of Herkimer and members of the public during times they are transacting business in a nearby County Building.

"Abandoned Vehicle" A motor vehicle shall be deemed an abandoned vehicle if left unattended for more than ninety-six hours upon any property designated by the County of Herkimer as a parking lot.

Section 2. Permitted Parking

Vehicles are permitted to be parked in County Parking Lots as follows:

- A. All-day parking is permitted to officers and employees of the County of Herkimer while working in the County Office Buildings in the Village of Herkimer.
- B. Short term parking is permitted to residents of the County of Herkimer and others in available space while transacting business in the County Office Buildings.

Section 3. Prohibited Parking

Parking of vehicles in the County Parking Lots is prohibited as follows:

- A. All-night parking.
- B. All-day parking by persons other than officers and employees of the County of Herkimer.
- C. Vehicles other than passenger cars and small trucks except with special permission from County enforcement officers and only in accordance with such permission.

Section 4. Enforcement

These Rules and Regulations shall be enforced by the County Administrator or his designee. Appropriate signs may be erected in the County Parking Lots to advise the public of the Rules and Regulations governing the use of said Lots. The County Administrator is authorized in his discretion to issue stickers to officers and employees of the County of Herkimer to identify vehicles for which all-day parking is permitted. Officers and employees of the County of Herkimer are allowed to park vehicles with such identification stickers in County Parking Lots during night hours when on county business. The County Administrator is authorized in his discretion to allow preferred parking in the County Parking Lots to officers or employees of the County of Herkimer who make application therefor, and to identify spaces for preferred parking by appropriate signs.

Section 5. Violations

Punishment for violation of this Local Law shall be as follows:

- A. Each violation shall constitute an offense, and the person guilty of such offense may be punished by a fine not exceeding \$100 or by imprisonment not exceeding 30 days or both such fines and imprisonment.
- B. This Local Law may also be enforced by imposing a penalty not exceeding \$100 in any one case to be recovered in a civil action in any court having jurisdiction thereof, which action shall be brought in the name of the County of Herkimer.
- C. Appearance tickets may be issued for a violation of the provisions of this local law, and a second and subsequent appearance tickets may be issued for each day of violation.
- D. The County Administrator may authorized not more than three officers and/or employees of the County of Herkimer to issue appearance tickets for violations of this local law. A certificate of authorization executed by the County Administrator shall be filed with the Clerk of the Legislature. A certified copy thereof shall be filed in the Court in which such appearance tickets are made returnable.

Section 6. Abandoned Vehicles

An abandoned vehicle, as defined in this Local Law, shall be removed from a county parking lot by order of the County Administrator or his designee. Disposal of such vehicle shall be governed by the provisions of Part 18 of Chapter 1, Commissioners' Regulations in Volume 15, Motor Vehicles, New York Code, Rules and Regulations.

LOCAL LAW NO. 3 - 1993

A LOCAL LAW CONCERNING DUTIES OF THE COUNTY PURCHASING AGENT

BE IT ENACTED by the Legislature of the County of Herkimer as follows:

Section 1. The Local Law known as "ACT NUMBER ONE-AN ACT TO ESTABLISH AND MAINTAIN AS A COUNTY CHARGE A PURCHASING DEPARTMENT IN AND FOR THE COUNTY OF HERKIMER, AND TO APPOINT A PURCHASING AGENT TO BE THE HEAD THEREOF," adopted by the Board of Supervisors of the County of Herkimer on the 20th day of February, 1933, to take effect on the first day of November, 1933, is hereby repealed except as set forth herein.

Section 2. The Purchasing Department established by the aforesaid Local Law is hereby continued to be operated with the powers set forth herein. The County Purchasing Agent appointed in and for said Department is hereby continued in office for the term for which he was appointed, with his compensation, and the compensation of County Purchasing Agents appointed hereafter, to be established by budgetary process. The County Purchasing Agent shall serve a term, the length of which shall be determined by Section 625 of the County Law of the State of New York.

Section 3. The County Purchasing Agent shall continue to have all of the powers and shall continue to perform all of the duties set forth in Section 625 of the County Law of the State of New York, and shall perform such additional and related duties as may have been, or in the future might be, prescribed by law and directed by the County Legislature; except that the County Purchasing Agent shall not hereafter have the duty to purchase or contract for such supplies and materials for the Highway Department of the County of Herkimer as are authorized to be purchased and contracted for by the County Superintendent of Highways, under the terms and conditions set forth in Section 133 of the Highway Law of the State of New York, and such supplies and materials for the Highway Department shall be purchased and contracted for by the Superintendent of Highways, or under his direction, and under the terms and conditions of said Section 133, and such other terms and conditions as have been or may be promulgated and established by the Legislature of the County of Herkimer.

LOCAL LAW NO. 4 - 1993

A LOCAL LAW AUTHORIZING PARTICIPANTS TO PROVIDE COVERAGE UNDER THE HERKIMER COUNTY SELF-INSURANCE PLAN TO VOLUNTEER AMBULANCE COMPANIES OPERATING WITHIN MUNICIPAL BOUNDARIES OF PARTICIPANTS AND TO APPORTION COSTS THEREFORE

BE IT ENACTED by the County Legislature of the County of Herkimer as follows:

Section 1. Section 1A of the Rules and Regulations for the Administration of the Herkimer County Self-Insurance Plan, enacted by Local Law No. 4 of 1956, as last amended by Local Law No. 1 of 1984, is hereby amended to read as follows:

A. PARTICIPATION

In addition to the County, participation in the Herkimer County Self-Insurance Plan shall be available to the City of Little Falls and the towns and villages located within the geographical boundaries of Herkimer County, and to any Joint Garbage, Metal and Refuse Disposal Districts comprised entirely of municipalities which are participants in the Plan. In addition, any participant or number of participants making application therefore, may extend coverage under the Plan to members of any volunteer ambulance service certified or registered under the Public Health Law of the State of New York or any other applicable state statute operating within the territory of such participant or participants.

Section 2. Section 1C of the Rules and Regulations for the Administration of the Herkimer County Self-Insurance Plan, enacted by Local Law No. 4 of 1956, as amended by Local Law No. 1 of 1967, and as last amended by Local Law No. 1 of 1984, is hereby amended as follows:

C. APPORTIONMENT OF COSTS

1. The apportioned share of each participant in the Herkimer County Self-Insurance Plan shall be based one-half (50%) on the total value of the participant's taxable real property in the proportion that the full valuation of its taxable real property bears to the aggregate full valuation of all participants; and one-half (50%) on the loss-percentile experience of the participant, said loss-percentile to be calculated based on the losses of each participant in relation to the aggregate losses of compensation and medical for the entire plan for each of the three preceding years, omitting the current year.

2. To participants not electing to cover paid police and firemen, the total of the several amounts set forth in the annual estimate prepared pursuant to Section 67 of the Workers' Compensation Law shall be apportioned to such participants in the proportion that 50% of the full valuation of its taxable real property bears to the aggregate full valuation of all participants, except that as to Joint Garbage, Metal and Refuse Disposal Districts and estimates shall be apportioned to participants in the proportion that 1% of the full valuation of the taxable real property of the municipalities which comprise said District bears to the aggregate full valuation of all participants.

3. To participants electing to cover either paid police or paid firemen, but not both, the total of the several amounts set forth in the annual estimate prepared pursuant to Section 67 of the Workers' Compensation Law shall be apportioned to such participants in the proportion that 75% of the full valuation of its taxable real property bears to the aggregate full valuation of all participants.

4. To participants electing to bring both paid police and paid firemen under coverage of the Herkimer County Self-Insurance Plan, the total of the several amounts set forth in the annual estimate prepared pursuant to Section 67 of the Workers' Compensation Law shall be apportioned to such participants in the proportion that the full value of its taxable real property bears to the aggregate full valuation of all participants.

5. Payment of claims previously paid or incurred by the County of Herkimer on behalf of the Joint Garbage, Metal and Refuse Disposal District known as the German Flatts, Ilion, Mohawk Joing Sanitary Landfill Corporation are ratified and confirmed subject only to application by said District to be a participant in the Herkimer County Self-Insurance Plan and acceptance of said application by the Herkimer County Legislature.

6. To participants electing coverage under the plan for volunteer ambulance service certified or registered for their municipality an additional allocation shall be made based one-half (50%) on the loss-percentile experience of the participant, said loss-percentile to be calculated based on the losses of each participant in relation to the aggregate losses of compensation and medical for the entire plan for each of the three proceeding years omitting the current year, and one-half (50%) based on the proportion its full assessed valuation bears to the aggregate full assessed valuation of the participants electing such coverage. Full assessed valuation shall mean the assessed valuation of real property divided by the latest rate as determined by the Herkimer County Legislature.

The amount to be used in computing the allocation for the one-half (50%) based on full assessed valuation shall be fifty percent (50%) of the charge set forth in the then current New York Workers Compensation and Employers Liability Manual for a Volunteer Ambulance Service Company for the number of ambulances being operated by volunteer service company.

Section 3. This Local Law shall take effect immediately.
