**Court documents will be rejected for filing if there is not an Index Number; filed in wrong court; not signed in accordance with 130-1.1-a Rules of the Chief Administrator; the summons, complaint, petition or judgment contains an etal or does not have a full caption; or is subject to electronic filing pursuant to 202.5-b Rules of the Chief Administrator.
