MINUTES Herkimer County Legislature Second Quarter – First Day Wednesday, April 13, 2016 2:00 p.m.

The Second Quarterly Session of the Herkimer County Legislature was called to order by Chairman Bernard Peplinski, Sr. at 2:00 p. m.

Chairman Peplinski called on Brynn Shepardson a 3rd Grader from Benton Hall Academy, Little Falls School, and Aiden Davies, a 4th Grader from Dolgeville Elementary School, to lead the Legislature in the Pledge of Allegiance.

Chairman Peplinski called for a moment of silence in recognition of all veterans, past and present.

Roll Call: Quorum present, the following answering the roll:

Pursuant to Rule 8 of the Rules of the County Legislature, Chairman Peplinski asked if there were any objections or corrections to the minutes of March 16, 2016. There were none, and the Chairman ordered them approved.

Chairman Peplinski dispensed with the Regular Session to allow for a presentation and called upon Legislator John Brezinski to make the introductions. Mr. Brezinski first asked for a moment of silence in honor of the 7 astronauts, including Gregory B. Jarvis of Mohawk, who died in the Shuttle Challenger disaster thirty years ago. Legislator Brezinski then introduced Frankfort native Scott Wilson, Engineer and Production Manager for NASA's Orion Program, Lee Morin, NASA Astronaut, and Debbie Sharp, Orion Communications with the NASA Johnson Space Center. Mr. Wilson first thanked Legislator Brezinski, Chairman Peplinski and County Administrator Wallace for extending the invitation for them to come before the County Legislature. He also thanked Mayor Leonard of Ilion, Mayor Lyon of Dolgeville and Mayor Blask of Little Falls for their attendance. He stated that Herkimer County has a long history of support for the space program, going back to Gregory Jarvis of Mohawk and including others like Herkimer native Mike Sarafin, who is mission manager for the exploration project, and Joe Farley, also a Frankfort native, who works for a contractor at the Kennedy Space Center that helped to build the International Space Station. He recognized John Piseck, of CTM Corporation, whose company in Frankfort builds things that are 230 million miles away from us on Mars. Mr. Wilson stated that during the morning they were sharing their experiences with over 500 students at both Frankfort Jr./Sr. High School and the Gregory B. Jarvis Middle School in Mohawk.

Their goal was to inspire and encourage students to pursue careers in science, technology, engineering and math (STEM), adding that the students were very enthusiastic and asked many interesting questions. Mr. Wilson gave a presentation on Orion, scheduled for launch in 2018 from the Kennedy Space Center, which is NASA's new Space Launch System, and will be the most powerful rocket ever built and will enable astronauts in the Orion spacecraft to travel deeper into the solar system than ever before. Mr. Wilson then introduced Lee Morin, a veteran NASA Astronaut since April 1996. Astronaut Morin shared some of his experiences during his over 250 hours, both in space shuttles and doing space walks. He gave a very detailed description of what it felt like to be in the space rocket during the launch process. Astronaut Morin concluded by saying that it is important for our youth to start learning technology at a very early age. Mr. Brezinski called on Nicholas Peretti a student from Rome, New York, who was invited to attend this presentation due to his passion and interest in pursuing a career in the space program. Mr. Brezinski then recognized Nancy Wilson to announce the winners of the NASA Art Contest for elementary students which was entitled "Journey to Mars - My Trip to Space". The two winners were Brynn Shepardson, a third grader from Benton Hall Academy in Little Falls and Aiden Davies a fourth grader from Dolgeville Elementary School, and their artwork will be on display at the Kennedy Space Center in Florida. Scott Wilson presented a citation plaque to Chairman Peplinski and Legislator Brezinski for the citizens of Herkimer County on behalf of the many men and women who were educated in Herkimer County and have gone on to be a part of the NASA space program. The plaque was in recognition of Herkimer County's long standing support and many contributions to the workforce of the NASA Space program. John Piseck from CTM Corporation in Frankfort was called on. He described his company's involvement in the design of the scoop that was made for the Mars Land Rover Project and several other NASA projects his company worked on. Legislator Brezinski thanked the NASA team for attending the session and for their presentation and in closing stated that we should remember "it's all about the kids".
