### REPORT AND RESOLUTION OF THE COMMITTEE ON HUMAN RESOURCES AND THE COMMITTEE ON WAYS AND MEANS CONCERNING SERVICES IN CONNECTION WITH THE EXPANDED IN-HOME SERVICES FOR THE ELDERLY PROGRAM

WHEREAS, pursuant to resolutions previously adopted, contracts were authorized between the Herkimer County Office for the Aging and At Home Care, Inc., the Department of Social Services, Home Aide Services for Central Adirondacks (HASCA) and Superior Home Health Care, for said contractors to provide services for the Expanded In-Home Services for the Elderly Program (EISEP); and

WHEREAS, by communication dated February 1, 2013, from Kathy L. Fox, Director of the Office for the Aging, this Legislature is advised of a request to enter into renewal of the aforesaid contracts for the period of April 1, 2013 to March 31, 2014 to fund case management, housekeeper/chore and homemaker/personal care services to the frail elderly not eligible for Medicaid; and

WHEREAS, by communication dated February 1, 2013, Kathy L. Fox, Director of the Office for the Aging, has further requested an additional new contract with the Resource Center for Independent Living (RCIL) to offer Financial Management Services for the Expanded In-Home Services for the Elderly Program (EISEP) Consumer Directed In-Home Services Program, with funding to be 75%/25% and the Office for the Aging will provide the local match; now, therefore, be it

#### RESOLVED:

- 1. That a contract be entered into between the Herkimer County Office for the Aging and At Home Care, Inc., 25 Elm Street, Oneonta, NY 13820 to provide such care for the frail elderly in the amount of \$106,550.00, which shall come from state funds, with the local match to be provided by the Office for the Aging. The hourly rate for service will be \$20.34 for housekeeper/chore and \$20.69 for homemaker/personal care, which may be renegotiated based on receipt of approved Medicaid rates;
- 2. That a contract be entered into between the Herkimer County Office for the Aging and the Herkimer County Department of Social Services to provide case management services in the amount of \$65,000.00; with state aid reimbursement of 75% up to \$48,750, with the local match to be provided by the Department of Social Services;
- 3. That a contract be entered into with Superior Home Health Care of Herkimer, New York, for contracted aide services estimated to be \$62,300.00, and local match to be provided by the Office for the Aging. The hourly rate for services will be \$18.75, which may be renegotiated based on receipt of approved Medicaid rates;
