WHEREAS, by Resolution No. 131 for the year 2022 duly adopted on April 27, 2022, this Legislature authorized and directed the sale at public auction, after due advertisement, of certain county owned tax acquired real property under the direction of the County Treasurer; and

WHEREAS, the Properties Committee of this Legislature reports that said sale was duly held pursuant to said direction on June 11, 2022 in Herkimer, New York; and

WHEREAS, pursuant to the terms of sale the successful bidder on each parcel sold is required to pay the full purchase price together with recording fee and transfer tax by July 5, 2022; and

WHEREAS, the Properties Committee reports that 54 bids were received at the auction, and the total amount to be received on said sales is \$1,001,000.00 as shown on the lists made available to each legislator and filed with the Clerk of the Legislature; and

investment, with the remaining fifty-percent to be distributed to the taxing jurisdictions on a pro-rata basis between the School, Town and County; and

WHEREAS, a PILOT Increment Financing Agreement would have to be approved by all of the taxing jurisdictions in order for it to take effect; and

WHEREAS, by letter of John J. Piseck, Jr., Chief Executive Officer of the Herkimer County Industrial Development Agency, dated June 29, 2022, a resolution is requested to authorize Herkimer County to serve as lead agency to complete appropriate state and federal environmental reviews regarding the Community Development Block Grant Coronavirus Aid, Relief and Economic Development Act (hereinafter "CBDG CARES-CV") Grant Number 528CVSB85-22; and

WHEREAS, by Resolution No. 99 of 2022, the Chairman of the Herkimer County Legislature was authorized to execute a grant agreement between the County and the Office of Community Renewal and all related documents, including entering into a grant agreement with the Herkimer County IDA for the implementation of said Grant; and

WHEREAS, the New York State CDBG Agreement for Project No. 528CVSB85-22 requires environmental review of the proposed project which is an award of \$500,000 for the Herkimer County CDBG CARES-CV grant; and

WHEREAS, by Resolution No. 99 of 2022, the County of Herkimer designated Vincent J. Bono, Chairman of the Herkimer County Legislature, as Certifying Officer for environmental reviews pursuant to the National Environmental Policy Act (NEPA) of 1969; and

WHEREAS, pursuant to the New York State Environmental Quality Review Act (SEQRA), the County of Herkimer is the sole Involved Agency because the proposed CDBG CARES-CV grant is not subject to approval of any other permitting or authorizing entities; and

WHEREAS, the project is categorically excluded from NEPA review pursuant to 24 CFR 58.35(b)(3) as a project providing capital to businesses in certain categories impacted by COVID; and

WHEREAS, Herkimer County understands that, except for actions involving activities determined to be Exempt (per 24 CFR 58.34 and NYS Office of Community Renewal Procedures), no physical alteration to individual sites can occur nor can funds for those activities be committed or expended until receipt of an environmental concurrence letter from the Housing Trust Fund Corporation and, for any subsequently identified specific sites, site-specific reviews are completed for which the Certifying Officer determines that there are no unanticipated impacts nor impacts not adequately addressed in the program review related to the environmental clearance letter and said Officer certifies such determination; and

WHEREAS, the County of Herkimer has caused a short form Environmental Assessment Form ("EAF") for the proposed grant that will fund activities to prevent the spread of the Corona Virus, respond to impacts of the virus, safely reopen and prepare businesses for new safety protocols; and

WHEREAS, the Herkimer County Legislature has reviewed the EAF for the proposed project and has identified and taken a hard look at the relevant areas of environmental concern; now, therefore, be it

RESOLVED, that the Chairman of the Herkimer County Legislature be authorized to certify that the proposed project is categorically excluded from NEPA review and any further NEPA certifications; and, be it further
