FROM BOARD OF ELECTIONS:

VICTIMS OF DOMESTIC VIOLENCE

N.Y. Election Law (5-508) allows victims of domestic violence to apply for a confidential registration by delivering a sworn statement to their local county Board of Elections stating they are a victim of domestic violence and they wish to have their voter registration record kept confidential because of the threat of physical or emotional harm to themselves or a family or household member. Their voter registration record will be kept separate and apart from other registration records for four years and not be made available for inspection or copying by the public or any other person, except election officials acting within the course and scope of their official duties. Under a separate section of the law (11-306), they can also be excused from going to their polling place to vote and get a special ballot. For further information, please contact your local board of elections for their confidential registration and special ballot procedures.

Primary Election Day is June 28, 2022. Polls are open from 6:00 a.m. until 9:00 p.m. Early Voting for the Primary begins on June 18, 2022 and continues until June 26. Hours and location of EV are available on our website www.herkimercounty.org/elections.

The General Election is November 8, 2022. More information will be coming over the next few months.

Also, because of extensive redistricting over the past several months, boundary lines for Congressional Districts, NYS Assembly and Senate Districts, Legislative Districts and Election Districts may have changed in most areas. New Legislative District and Election District maps are posted on the County website.

KRISTIAN

Kristian first came to the Herkimer Working Solutions Career Center in 2015, then 14 years old, to apply for a job in our Summer Youth Employment Program (SYEP). He worked through this program for 6 summers, gaining valuable experience in the areas of building maintenance, landscaping, the culinary arts, and automotive technology. His worksites have included the YMCA, Herkimer BOCES, and the Herkimer County Sewer District.

When Kristian graduated from high school in 2020, because his supervisors at the Sewer District had been very pleased with his previous work there, we again placed him there for the summer. In addition, as an out of school youth, he was now eligible for more extensive services in our year round program. As part of this program, we helped Kristian think about and identify what he felt were his short term and long term goals in terms of future employment. He expressed that, of all the summer jobs he had had, he was most happy when he was performing the kind of physical work he had done at both the YMCA and the Sewer District.

When the SYEP came to a close in August of 2020, and with the agreement of his supervisor, we were able to offer Kristian a fully paid, 200 hour work experience at the Sewer District through our Out of School Youth (OSY) Program. In addition to the landscaping and janitorial duties he had done throughout the summer, Kristian was taught the daily tasks of a Wastewater Treatment Plant Operator, and he started to gain an understanding of the scientific and engineering sides of the job. Because his performance reviews were consistently positive, and his work at the plant was valued, we decided to extend his work experience program again, giving him another 200 hours!

Once he successfully completed the additional hours, Kristian immediately found part time unsubsidized employment stocking grocery shelves at Hannaford Supermarket. Five months later, after saving up enough money to get his driver's license and a reliable car, Kristian secured full-time employment at the Tractor Supply Distribution Center as a general warehouse attendant, where his duties include, picking and packing orders, preparing boxes for shipment, and moving materials around the warehouse as needed.

Kristian continues to work at both Tractor Supply and Hannaford and is doing well at both places. His success is a credit to his incredible work ethic and the opportunities afforded him through both the Herkimer County Summer Youth Employment Program and the Out of School Youth funding that was used to help him realize his goals!

DID YOU KNOW??? HEADLIGHTS OFTEN MISUNDERSTOOD BY DRIVERS

How much do you know about your vehicle's headlights? Unfortunately, a large percentage of drivers don't know very much. Many don't even know if their vehicle has daytime running lights (DRLs) or not. And, many also don't know exactly what the various headlight switch positions, normally on the turn signal lever, mean.

Most vehicles that also have DRLs have four positions on the knob on the end of the turn signal lever – off, full headlights, parking lights, and automatic (AUTO). Headlight controls may be somewhat different for different car manufacturers so drivers should review their owners manual to see exactly how each position functions. I have a Subaru – it has DRLs and includes automatic headlights that fully turn on at dusk and whenever the wipers are on. I normally leave the headlight control on AUTO. However, at times when it is not dark enough for the full headlights to come on but there is some fog or snow, I will turn the light control switch to full headlights. Even on this function, the lights will turn off when the ignition key is removed.

When in the "off" position, the DRLs will still come on when the vehicle is not in the "park" position. I never operate in this mode. Also, I will never operate in the "parking light" position, as this should be used only when parking, not when driving.

The number of cars driving in darkness with headlights switched off has risen sharply over the past decade. This is because most new vehicles are equipped with hi-tech instrument displays that are illuminated day or night – whether headlights are switched on or not. If the vehicle doesn't have automatic headlights, a driver may be operating with just DRLs only, even after dark, as the DRLs are normally bright enough, and with the dashboard lights illuminated, the driver may think his/her headlights are on. This is referred to as a "phantom vehicle".

Canada just passed legislation, known as the Canadian Vehicle Lighting Regulation, requiring any vehicle with DRLs, which is most all vehicles in Canada since all cars manufactured in Canada have been required to have DRLs since 1989, will have to also turn on the taillights when the DRLs come on. Second, headlights, taillights, and side marker lights will have to turn on automatically when it's dark out. Third, the dashboard must stay dark until headlights are turned on, to make sure the driver realizes that their lights are off. All new vehicles—including cars, trucks, SUVs, three-wheeled vehicles, motorcycles, and heavy trucks—sold in Canada will be subject to this new regulation. A survey of American drivers asking if the US should adopt this kind of legislation showed 84 % in favor and only 16 % opposed. This is convincing evidence that US drivers favor legislation that enhances vehicle safety, and they should.

The Insurance Institute for Highway Safety, the agency that crash-tests vehicles and rates them for safety, added a headlight rating program in 2016 that has spurred industry changes that are reducing dangerous nighttime crashes in the real world. Next week's DYK article will be about better headlights linked to lower crash rates.

Project No. 411 - Meeting House/Cross Rds Engineering and Design, CR172/195

Project No. 412 - North Winfield Rd Rehabilitation Project, CR119

Project No 413 - Wiltse Rd Bridge Replacement Project Engineering and Design, CR95

Project No 414 - North Street Reconstruction Project, CR67

Project No 415 - Shoemaker Rd Rehabilitation Project, CR68

Project No 416 - Meeting House/Cross Rds Rehabilitation Project, CR172/195

Project No 417 - Ashe Rd Bridge Replacement Engineering and Design, CR246

Project No 418 - Welshbush Rd Large Culvert Replacement Project, CR13

The total estimated cost remaining for design, construction, and construction inspection is \$9.5 Million. Funding for these projects comes from a variety of sources, which includes: FEMA, Dept. of Homeland Security, American Recovery Plan, Federal Aid, Marchiselli Funds, and the

Consolidated Local Streets and Highway Improvement Program.

New Emergency Management Certificate Program Offered

Herkimer County Community College has established a new Emergency Management certificate program aimed to provide the contemporary knowledge and expertise to lead, manage, or support disaster mitigation, preparedness, response and recovery in emergency management.

This online, one-year comprehensive program begins in the fall 2022 semester and is designed for transitioning professionals and individuals seeking industry-specific course work essential to support whole community emergency management programs. It is the only online certificate program of its kind in the Mohawk Valley region; and Herkimer College is one of the only colleges in the state to offer an online emergency certificate program at this level.

According to Herkimer College Associate Dean of Academic Affairs Robin Riecker, Ed.D., this advanced program is delivered by experts in the field.

"Our instructors bring extensive practical experience from FEMA, state emergency management agencies, local government, and the private sector," Riecker explains. "We teach not only what should be done, but how to do it, based on existing standards and best practices." Successful graduates of the program will be able to apply a knowledge base of necessary skills to include whole community critical incident management, emergency planning, emergency operations center organization and management, resource and capability planning, and the application of national emergency management standards prior to, during, and in the aftermath of disasters.

Coupled with other academics and/or experience, certificate holders may qualify for positions at local, state, or federal agencies; in the private sector; or non-profit organizations in such roles as emergency management specialist, emergency planner, emergency management coordinator, emergency preparedness coordinator, emergency management program coordinator, and business continuity specialist

Herkimer's Emergency Management program was designed utilizing industry standards such as the National Incident Management System (NIMS), the National Preparedness Goal, the Homeland Security Exercise and Evaluation Program (HSEEP); and NFPA 1600: Standard on Continuity, Emergency, and Crisis Management. The program also integrates FEMA incident command system (ICS) training courses. Students enrolled in this program may be eligible for financial aid. To learn more about the curriculum, cost of attendance, financial aid, or to apply for the Emergency Management certificate program, visit www.herkimer.edu/EM.

Here are some key takeaways:

Hiring Details

- Currently accepting those with or without GED/HS Diploma
- Must be 18+ and understand English
- Background issues-honesty is key-will look at on a case by case basis
