The Special Session of the Herkimer County Legislature was called to order by Chairman Bono at 6:45 p.m.

**RESOLUTION OF THE COMMITTEES ON EDUCATION, WAYS AND COUNTY PROPERTIES APPROVING ESTABLISHMENT OF THE LIVING LEARNING HEALTH SCIENCE CENTER PROJECT AT HERKIMER COUNTY COMMUNITY COLLEGE**

WHEREAS, the Board of Trustees of Herkimer County Community College has, by Resolution No. 12-09, dated January 8, 2013, approved the capital budget for the construction of the Living Learning Health Science Center in the amount of \$3,000,000, with 50% of the local share coming from various sources and 50% from the state; and

WHEREAS, the project will provide an innovative collaborative living learning community that will complete the continuum of care for seniors in our region while producing a credentialed direct health care workforce; and

WHEREAS, said resolution requests that the Herkimer County Legislature adopt a similar resolution to approve this project; now, therefore, be it

RESOLVED, that the establishment of the Living Learning Health Science Center Project is hereby approved by the Herkimer County Legislature; and, be it further

RESOLVED, that the aforesaid project will be funded with 50% of the project cost to come from the state and 50% of the project to be the local share from various sources; and, be it further

RESOLVED, that certified copies of this Resolution be forwarded to the Herkimer County Treasurer, Auditor, Budget Officer, President of Herkimer County Community College and Vice President for Administration and Finance at Herkimer County Community College.
