First Quarter – Second Day
Wednesday, January 18, 2012
7:30 p.m.

The Regular Session of the Herkimer County Legislature was called to order by Chairman Vincent Bono at 7:30 p. m.

Chairman Bono called on Bernard Decker, Budget Officer and Purchasing Agent, to lead the Legislature in the Pledge of Allegiance.

WHEREAS, by letter dated January 10, 2012 from Mary A. Scanlon, Director of the Office for the Aging, this Legislature is advised of a request to enter into contracts with the Utica neighborhood Housing Service, Inc. (also known as The HomeOwnership Center) and the Herkimer-Oneida Counties Comprehensive Planning program to provide services in connection with the implementation of a Housing Rehabilitation program for Seniors – Countywide to assist elderly low income homeowners to address emergency repairs through a three-year forgivable loan program; and

RESOLUTION OF THE COMMITTEE ON PUBLIC SAFETY AND EMERGENCY MANAGEMENT AND THE COMMITTEE ON WAYS AND MEANS AUTHORIZING LEGAL PROCEEDINGS BY THE COUNTY OF HERKIMER AGAINST THE VILLAGE OF HERKIMER IN CONNECTION WITH PROPOSED NEW HERKIMER COUNTY CORRECTIONAL FACILITY SITE

WHEREAS, by Resolution No. 250 adopted by this Legislature on October 5, 2011, the County of Herkimer authorized legal proceedings against the Village of Herkimer in connection with the denial by the Village of access to its sanitary sewer system for the proposed New Herkimer County Correctional Facility at the former P& C site on New York State Route 28 in the Village and the Town of Herkimer; and

WHEREAS, that litigation was commenced by Notice of Petition and Petition dated December 7, 2011; and

WHEREAS, thereafter, it came to the attention of the County of Herkimer, pursuant to notice published in the newspaper, that the Village of Herkimer had scheduled a public hearing on December 19, 2011 regarding amending its zoning ordinance, and said public hearing was held on December 19, 2011 by the Village of Herkimer at which time the Village Board voted to refer the matter to Oneida-Herkimer County Planning for further proceedings; and

WHEREAS, the County of Herkimer has obtained a copy of the proposed local law which would amend the Village's zoning ordinance to prohibit, at this late date, a correctional facility, correctional institution or jail on the proposed site for the New Herkimer County Correctional Facility;

WHEREAS, the County of Herkimer has expended substantial resources in connection with the acquisition and development of the proposed site, all of which have been known to the Village of Herkimer for many months; and

WHEREAS, proposed amendment of the Village's zoning ordinance could cause substantial expense and delay to the County of Herkimer if allowed to be enacted; now, therefore, be it

RESOLVED, that litigation is hereby authorized against the Village of Herkimer to obtain an order to prevent the Village of Herkimer from amending its zoning ordinance in order to attempt to prevent substantial damage to the taxpayers of the County of Herkimer, with the Chairman of this Legislature being authorized to sign all necessary legal documents to commence and proceed with this litigation; and, be it further
